### COVID-19 Vaccination

We invite Molina Apple Health members to earn a **\$100 Amazon.com Gift Card** for getting your first dose of the COVID-19 Vaccine between June 1, 2022 and December 31, 2022. The vaccine is available at no cost to you.

According to the Centers for Disease Control and Prevention (CDC), studies show that the vaccine can keep you safe from getting severely ill from COVID-19 and spreading it to others. The vaccine trains the body to build defenses to the virus that can keep you from getting very sick, even if you do get COVID-19. There are currently three different vaccines available:

- *Pfizer-BioNTech (ages 6 months to 4 years): A three-dose series. The 1st and 2nd doses are 3-8 weeks apart, and the 2nd and 3rd doses are at least 8 weeks apart*
- *Pfizer-BioNTech (ages 5+): A two-dose series given 3-8 weeks apart*
- *Moderna (ages 6 months+): A two-dose series given 4-8 weeks apart*
- *Johnson & Johnson's Janssen vaccine (ages 18+): Single dose*

A booster dose is recommended for ages 5 and older after completing one of the vaccine series above.

#### Current Booster Dose Recommendations:

Who?	When?
Ages 5 and older and completed the Pfizer-BioNTech vaccine series	At least 5 months after the final dose in the primary series
Ages 18 and older and completed either the Pfizer-BioNTech or Moderna vaccine series	At least 5 months after the final dose in the primary series
Ages 18 and older who completed the Johnson & Johnson's Janssen vaccine series	At least 2 months after the final dose in the primary series
